SPECIAL PROJECT COORDINATOR MESSAGE

(Kim Williston)

I commenced my role as Special Projects Coordinator in late January 2024. The two priority projects for this role are: Standards of Excellence Accreditation and Emergency Preparedness and Response Planning. These projects address critical areas of process improvement for Food Banks Alberta.

Standards of Excellence Accreditation. This project focuses on ensuring that all food banks across Canada, including Alberta, adhere to and comply with a series of standards which promote best practices in food bank operations. Food Banks have recognized the need for a set of standards that create benchmarks while promoting transparency and accountability to the public. In response to this need, Food Banks Canada (FBC) formed a National Standards Committee who developed the Standards of Excellence Accreditation program.

Project Goal: The overarching goal is to ensure that every Food Bank in Alberta complies with the Standards of Excellence and submits their completed application to Food Banks Canada by March 31, 2025. The completed applications will be reviewed by the FBC National Peer Review Team.

Over the past 5 months, I have completed the FBA's Standards application, which was submitted in May 2024. I have provided support to food bank members across Alberta to assist with the completion of the seventy-two (72) Standards. Support has been provided in numerous ways including phone calls, one-to-one meetings, resource sharing, and webinars. Webinars are hosted monthly; each webinar covers one section of the standard. Examples, templates, and a variety of resources are provided. All information will be accessible through the Standards page on the member portal of the new FBA website.

Next 6 months: There are two overarching priorities over the next 6-9 months with this project:

On-going member support to assist in completing the Standards of Excellence.

 While food bank members in Alberta support best practices and some degree of standardization, it has become evident that there are areas of the Standards that are problematic and/or don't align with provincial health regulations. FBA and FBC are continuing to consult to determine how to meet he needs of all food banks in Alberta.

Emergency Preparedness and Response Planning. This project focuses on ensuring Food Banks Alberta has the resources needed to provide a comprehensive and coordinated response to food insecurity during emergency events. The Government of Alberta (GOA) is a key stakeholder in this project.

Over the past 5 months, I have supported the Executive Director in developing a proposal for the GOA to advocate for core funding to support FBA in emergency preparedness and response. This proposal established the essential role FBA plays in emergency response. I have also started to work on the FBA Emergency Preparedness Response Plan Manual and assisted in creating the process for internal protocols for members needing to access food support. I am also actively engaged as the FBA representative on the Non-Government Organization (NGO) Council of Alberta. These groups of non-profit organizations meet regularly to coordinate response in the event of an emergency.

Project Goal: It is important that FBA can respond to all food bank members during emergencies, including those food banks not impacted by the emergency. Therefore, the goal is to create an Emergency Preparedness and Response Plan for FBA. This Plan will serve as a go-to document for the oversight of emergency preparedness and response as it relates to food insecurity in Alberta.

Next 6 months:

Focus on the development and completion of the Emergency Plan and Manual

FOOD/WAREHOUSE MANAGER MESSAGE

(Fran Riehl)

I have been with FBA since 2021 and have worn many hats: warehouse manager, member services, network support, etc. As our team expanded however, my position has shifted to focus primarily on food procurement and warehouse supervision. Food insecurity continues to increase across the province, so it is imperative as an organization to form closer connections and partnerships with primary donors in agriculture (Potatoes, Corn, etc.) and protein (Bison, Beef, Chicken, etc.) sectors and to focus on moving these procured resources to our members in more efficient and cost-effective manners.

Accomplishments in last 6 months:

Bulk purchasing program. Re-launching the bulk purchasing program for the allotment this year. It was a program previously available to members a few years ago but had no reliable budget available to implement in large and consistent quantities. This year, in partnership with Food Banks Canada and The For Good Foundation, we were able to secure brand-new low-cost goods that were in high demand for the network, utilizing a larger purchasing budget than the previous years. For the steady rotation of staple foods, systems had to be designed to implement, track, and monitor the movement and resale of this food. By doing so, the warehouse's ability to forecast purchases increases. Members who have limited resources in their communities or were not in a 'ship to zone' from wholesalers directly are now able to procure resources at greatly reduced rates directly from our warehouse.

Upcoming projects:

Some of the upcoming projects currently in development include a program for uninspected eggs (in partnership with AHS), securing no-cost or donated transportation partners, modifying the allotment program for better equitability, and (re)forming partnerships with primary donors in the agriculture, protein, and fresh sectors.

The Olive Tree Community Centre is a unique organization that offers support in the areas of homelessness, hunger relief and education. Through their food bank programs, they are able to distribute over 300,000lbs of food a year in their community and the surrounding area. The social enterprise that they operate provides essential support to community members through the provision of clothing, household items, and furniture. They are a vital resource that not only addresses immediate needs like food insecurity, and necessities but also fosters community well-being through education, outreach support, and social initiatives. Their efforts contribute significantly to enhancing the quality of life for many residents in the area.

2023 STATISTICS

In 2023, Food Banks Alberta exceeded donation amounts that haven't been seen since COVID-19 relief efforts in 2020. We tracked a total of 105 donation offers over the course of the year, including wildfire emergency relief, NWT evacuee relief, and Kraft Pantry days (Quarterly donations in partnership with Food Banks Canada).

The allotment system, although still far from perfect, simultaneously managed to substantially increase the number of members accessing

our warehouse stocks, the number of requests made for food, shipments, and overall movement of food. Our transportation and storage expenditures have, as a result, also increased with the growing need from our members. For example, external storage and transportation were under \$3,000 combined per month by the end of 2020. Late in 2022, we saw expenditures jump to a combined average of over \$6,500 per month

Distribution to our food bank members reached an all-time high in 2023 at **2,038,465lbs** shared. Since 2020, the average number of food banks served by Food Banks Alberta increased by **175.68%**

to move allotments requested/ordered. As a result, in 2023, we worked hard to organize bulk shipments to hubs and formed a new partnership with Rosenau for better freight rates.

On May 06, 2023, the government of Alberta officially declared the province in a State of Emergency. Food Banks Alberta prioritized support for all affected communities and evacuees, but staff were also steadily

working on allotments submitted each month. The team further made a few calls for member support for those impacted by the wildfires. The NGO council was activated at the start of the emergency and a great deal of support was funneled through Food Banks Alberta into impacted communities. A second round of emergency relief was activated when the fires up North and in BC forced evacuees into Alberta on Aug 15, 2023. As a result of FBA's emergency efforts in 2023, the GOA proposed a contract with our organization to provide emergency relief to food-insecure communities during emergency events (local or provincial level).
